DEPOSIT, PLUS 6% INTEREST, WILL BE RETURNED AFTER 1 (ONE) YEAR TO APPLICANTS IF BILLS ARE PAID ON OR BEFORE THE DUE DATE EACH MONTH. IF YOU DISCONNECT SERVICES BEFORE DEPOSIT IS RETURNED, FINAL BILL WILL BE PAID FROM DEPOSIT AND REMAINDER OF DEPOSIT BALANCE RETURNED TO APPLICANTS.
